The Chairman invited all to enjoy lunch.

Chairman Johnson asks for a motion to **approve the minutes** of June 19, 2019 Full Board Meeting. The motion is made by Dwight Coburn and second by David Lieving.

Melissa Bias presents an overview of the Youth Program.

The **Legal Report** was not presented, due to the absence of Timothy LaFon.

The Financial Handouts were given to attendees.

Claude J. Hunt presents the **Executive Director Summary**: Region 2 will hold a Career Fair in Logan on November 14, at Chief Logan Lodge. The Career Fair is open to Veterans Only from 9-10AM and is open to all from 10 until 2:00. The Q4 Performance Report was handed out, indicating a good report for Region 2, save for Disloacted Worker median earnings and the Youth employment rate. Region 2 provided Rapid Response services on Monday, September 16 to the persons laid off in Boone County. The excel Contract has been renewed, we await the ABAWD Contract renewal. Region 2 will be participating in the Parent Advanced Training sessions, which will be held at the high schools in our region. Region 2 Board has been certified by Governor Justice for 2 years; until June, 2021. Scott Adkins has replaced Russell Fry as Acting Commissioner of Workforce WV.

There was no **Old Business** before the membership.

- 5. PY18 State Performance Report for the 4th quarter. Is a handout and requires no board action.
- 6. Approval is requested to transfer PY18 DW funds, up to \$300,000.00 to AD funds. Motion is made by David Lieving and second by Allissa Stewart Sparks.
- 7. Evening Schedule for Parent Advanced Training is a handout. No action is required.
- 8. Board Members are asked to sign the Conflict of Interest form and return it to Region 2 WIB.
- 9. Approval is requested for WIOA funding PY 19 July 1, 2019-June 30, 2021. The funding available for Adult, Dislocated and Youth total \$2,418,608.00. Motion is made by Nancy Shepherd and second by James Hosier.
